IX. Old Business

- 1. Proposed changes to the Joint Policy on Philanthropy & Fundraising
 - a. If fundraising for a non-501(c)(3) written documentation must be provided to the participants/donors that their donation is not tax deductible.
 - b. 1 pass unanimous
 - c. “Chapters may not generate revenue from the sale of chapter members or other human beings or their direct services. This includes but is not limited to goal trackers that promote bodily physical violence, high risk activities, objectification, or degradation. Chapters may participate in auctioning experiences or other goods.”
 - i. Does not pass (10 Yes, 10 No)
 - d. ”9. Drives/Collections held at philanthropy events must include clear and informative signage on where items are being donated.”
 - i. Pass (unanimous Yes)
 - e. “8. Signature Events and Drop -In Events will not be confirmed if scheduled during Programming Board Signature Events, such as Ram Rhythm and Lip Sync Battle. (This restriction does not apply to social media competitions hosted by Programming Board.)”
 - i. Does not pass (unanimous no)
 - ii. Ask for clarification of wording to state “If a chapter registers their event prior to release of programming board event their event can remain”
 - f. “1. No chapter should co-sponsor an event with an alcohol distributor or tavern (tavern defined as an establishment generating more than half of annual gross sales from alcohol) at which alcohol is given away, sold, or otherwise provided to those present. Chapters may not generate revenue from the sale of alcohol.”
 - i. Does not pass (3 Yes, 17 No)
 - g. “5. Eating contests or the rapid consumption of food or beverages is prohibited.”
